

## THE REPORT OF THE BOARD OF ORDAINED MINISTRY

We appreciate you reviewing our report to the 2025 South Carolina Annual Conference, which you can read at [umcsc.org/ac2025](http://umcsc.org/ac2025).

The Board of Ordained Ministry comprises clergy and lay members who provide faithful servant leadership. We invest our time and share our unique gifts in leadership development with the candidates. We continually pray to affirm each candidate's call to ministry. We walk alongside and nurture candidates who seek ordination to encourage excellence, demonstrate compassion, listen attentively, and ultimately guide candidates toward progress—from being prepared to becoming fit for ministry.

We are forever grateful for each member of the Board of Ordained Ministry so that we can develop excellent leaders in various ministry settings. The Board is divided into seven reading teams. The team comprises two members from each subcommittee: Bible Study, Call and Disciplined Life, Proclamation and Preaching, and Theology and Doctrine. Each member reads all work submitted to gain a holistic approach from the four evaluative areas. The hope is that the interview will be more conversational. The goal remains the same. We will continue to work efficiently and be faithful in our two primary responsibilities: developing leaders and credentialing clergy.

On Sunday evening, June 8, 2025, at 7 p.m., the Service of Commissioning and Ordination will be held at the Greenville Convention Center to celebrate the fruit of persons who have answered a call to ministry and successfully navigated the requirements for commissioning and ordination. These people are valued as meeting the standards of readiness and effectiveness for ministry in the local church and other ministry settings.

Three people are scheduled to be ordained as full elders: Leo Wesley Roy, Thessa Goodwin Smith, and Billy Keith Stewart.

One person will be ordained as a full deacon: Kim Moultrie Bryant.

Eight people will be commissioned as provisional elders: Grayson Edward Fallaw, Joseph Brannon Gambrell, Rachel Elizabeth Headden, Faye Juanita Jones, Fred Preston Moore, Jr., Larry McCray, Adrienne Elaine Stokes, and Sheera Disher Yates.

Two people will be commissioned as provisional deacons: Heather Roberts Connor and Ronald Brent Crimm.

Gary Rivas, who was previously ordained in another Methodist denomination, will have his orders recognized and will be received as a full member of the South Carolina Annual Conference.

Patrick Taylor, who was previously ordained in another Methodist Denomination, will have his ordination recognized and is being received as a local pastor of the South Carolina Annual Conference.

We sincerely thank everyone who has answered the call to ministry and committed themselves to their education, commissioning, and ordination. We ask for God's blessings on their ministry, mission, service, and witness journey. We encourage all local churches and ministry settings to invite individuals to explore their calling to ministry and to nurture that calling into leadership through prayer.

The Board of Ordained Ministry will recognize the people who have completed the five-year Basic Course of Study for 2024 and received United Methodist Special Sunday scholarships at the Annual Conference.

We want to express our gratitude to local churches and the Annual Conference for their support of the Ministry Education Fund. Your generous contributions have enabled the Board of Ordained Ministry to assist students financially, significantly reducing educational costs.

We encourage you to continue your faithful support for our future leaders who are committed to their leadership development and strive for excellence in ministry. Please send your offerings to the S.C. Conference Seminary Students Scholarship Fund, which the South Carolina United Methodist Foundation manages. This endowment provides scholarships to candidates for ministry from South Carolina attending United Methodist seminaries and theological schools.

1 We genuinely appreciate your financial gifts, and will update you on the recipients during the Annual  
2 Conference.

3 District Committees on Ordained Ministry play a vital role in the ministry process by meeting with all  
4 candidates for ministry. They serve as an extension of the Board of Ordained Ministry, providing essential  
5 support and accountability for individuals. The Board of Ordained Ministry profoundly appreciates the hard work  
6 and dedicated service of every District Committee.

7 We celebrate God's call for individuals to serve, lead, and experience the joy of ministry. Ministry is a continuous  
8 journey, and we are committed to providing growth opportunities. The Board of Ordained Ministry works diligently  
9 to plan the annual Bishop's School of Ministry and Clergy Orders gatherings. We actively recruit and engage  
10 seminarians as potential leaders in the South Carolina Conference. Additionally, we discern and process Extension  
11 Ministry requests as the ministry landscape evolves, and we participate in the Approval for Service requests for  
12 those seeking to join our Annual Conference. We actively receive and carefully consider requests for status changes  
13 from candidates and clergy. Additionally, we engage with individuals who feel a call to ministry through our  
14 Candidacy Retreats. These are just a few of the Board of Ordained Ministry's ongoing responsibilities.

15 As the Board of Ordained Ministry in the South Carolina Conference, we depend on the support of our local  
16 churches to identify and nurture candidates interested in pursuing ministry. We are committed to providing holistic  
17 and accountable care to everyone called to serve Jesus Christ. Although our congregations may have evolved, we  
18 firmly believe that ministry can bring hope, joy, and grace to our lives. As a team, we pledge to address the needs of  
19 everyone on their ministry journey attentively.

20 The Board of Ordained Ministry would like to express our heartfelt gratitude for the dedicated and capable  
21 leadership of two extraordinary individuals. First, we want to acknowledge the efforts of Rev. Mel Arant, the  
22 Coordinator of Clergy Services. Second, we recognize the exceptional contributions of Mr. Sharome Henry, the

24 invaluable to our Board. We understand that the efficient execution of our tasks would not have been possible

### 31 **THE COMMISSION ON ARCHIVES AND HISTORY**

32 The commission on archives and history maintains the conference's historical records and helps researchers –  
33 conference officials, local church historians, genealogists, or scholars – learn about Methodism in South Carolina. We  
34 maintain archival repositories at Wofford College and Claflin University. We are also responsible for recommending  
35 historic sites and promoting history in the conference.

36 The biggest challenge we've faced this year is taking the records of churches that were separating from the  
37 conference. In the separation agreement, churches had to submit digital copies of their membership and some  
38 administrative and historical records. We had to manage the transfer of those records and insist that some churches  
39 comply. And then, we had to process those records and make them available in our digital repository.

40 Our archivist, Phillip Stone, published a book of his columns on Methodist history in South Carolina with the  
41 Advocate Press.

42 With all the work of collecting and processing separating church records, we still managed to help 227  
43 researchers with history or genealogy questions.

44 The archives tries to make more records available for researchers and will continue to do that this year.

45 We have a group of new archives and history commission members that we hope will bring new ideas.

1 We are ready to collaborate with any group who wants help in sharing history, but also in using history to  
2 help share the story of United Methodism in South Carolina.

3 We would like to express our gratitude to Chancellor Kay Crowe for her strong support of the commission's  
4 efforts to collect records from the separating churches.

5 You don't always realize how much you need the archives until you suddenly need them. The archives is here not  
6 just to maintain the records of the past, but to maintain the records we produce today so that the future also has a  
7 past. Archives and history are as much about who we are today as who we were in the past. And, ultimately, archives is  
8 about stories that connect us together across the generations.

13 Whereas, in 2023 and 2024, 225 congregations in the South Carolina Annual Conference separated from the  
14 conference; and

15 Whereas, the United Methodist Book of Discipline places the responsibility of caring for the records of closed local  
16 churches with the Conference Commission on Archives and History; and

17 Whereas, as part of the separation process, congregations were requested to deposit certain of their membership,  
18 administrative, property, and historical records with the Commission on Archives and History; and

19 Whereas, as the South Carolina Annual Conference Chancellor, Kay Gaffney Crowe was responsible for enforcing  
20 the various separation agreements signed by the separating churches, and

21 Whereas, her insistence that local churches comply with their agreement to deposit copies of their historically  
22 significant records with the Commission on Archives and History resulted in the preservation of over 200 sets  
23 of church records, and

24 Whereas, the preservation of these records provides an invaluable service to those individuals in the future who will  
25 be able to access those records for genealogical and historical research, now,

26 Therefore, be it resolved by the South Carolina Annual Conference Commission on Archives and History, that we  
27 are grateful for the support of Conference Chancellor Kay Gaffney Crowe in ensuring the transfer of local  
28 church records to the archives; and

29 Be it further resolved, that we extend our sincere thanks to her for her firm insistence that separating churches  
30 fulfill their responsibilities in transferring their permanently valuable records to the archives before leaving  
31 the conference.

Specifically, we believe that:

- the venue cost is reasonable and affordable for the Annual Conference

- the hotels are located close to the venue and reasonably priced for the season
- restaurants and local vendors are plentiful and easily accessible
- the venue is geographically central to all areas and persons in the state
- the venue provides excellent parking space and is handicap accessible

The committee expresses gratitude to the Host/Logistics team under the leadership of Chris Lynch. This team together with the VisitGreenvilleSC Staff have worked tirelessly planning, arranging and carrying out important details. The fact that many of these details will go unnoticed is a testimony to their hard work. Their work could not be done without our host church, St. Mark United Methodist Church, “the 911” and its team under the leadership of Rev. Carlton McClam. The Worship team under the leadership of Rev. Beverly CroweTipton has also worked overtime to insure that our time together is both productive and meaningful. The committee is also thankful for the work of the Future Sites team for the extra hours given to review and evaluate future site proposals. A special word of gratitude is offered to Pat Mack and Sharome Henry for once again going above and beyond the call of duty in this conference season.

#### **THE COMMITTEE OF CONGREGATIONAL DEVELOPMENT 2024-2025**

##### **Purpose:**

The purpose of the Committee of Congregational Development shall be to work with the Bishop and Cabinet (Appointive and Extended) to provide long and short term planning and provide the framework for all the efforts of the Annual Conference related to new church development, church redevelopment and congregational revitalization. We exist to continue finding ways to create new opportunities, new places, and new spaces for new people. We work with existing congregations to develop processes to revitalize and develop transformative and impactful ministries and some building projects so that we are able to develop more maturing world-transforming disciples of Jesus Christ. We work with the District Boards of Congregational Development, the Cabinet and Connectional Ministries to identify, resource, assist, support, fund, discover where to deploy planters and develop new church plants, missions, ministries initiatives to reach the people of existing, new communities and changing areas across the state of South Carolina. We strive to be a vital resource for local pastors and laity of local congregations as we seek more excellent ways to share the loving gospel of Jesus Christ and Christ Church in extending the Kingdom of God to all of creation.

##### **Key moments from the previous year:**

The Conference Committee formed a Task Committee to consider how we would utilize the one million dollars granted to Congregational Development from the Conference Trustees from the 2023 Separation Church funds. The task committee discussed over several meeting the best use of the Separating Church Funds received from the Conference Trustees. After several meetings and much discussion, the Task Force presented to the full committee for approval of the following distribution of the funds:

1 **Campus Ministry Grants – \$150k** available to ensure programming monies are available for campus ministry  
2 areas so that campus ministries can continue investing in discipleship, growth, and development of present and  
3 future transformative leaders of college aged young adults. We see this an investment in the present and future  
4 of the kingdom of God and the ministries of the United Methodist Church Campus Ministries. All the campus  
5 ministries in our Conference received an initial grant of \$8,333.00 in support of developing or enhancing their  
6 discipleship ministries on each of the sponsoring campuses across the state.

7 **Secondly, 6 Beta Cohorts - \$100k** to develop Bi-District cohorts across six months with three modules to help  
8 local churches (clergy and lay people) to cultivate discipleship pathways for the greatest missional impact. The  
9 funds will be used to help cover administrative costs and to invest in the findings of those churches participating.  
10 We believe this will foster a collaborative learning environment among our local congregations and communities  
11 across the Annual Conference.

12 **Third, support for Annual Conference Mission and Ministry Grants - \$450k**—these funds will support initiatives  
13 for new churches, new faith expressions, and new ministries opportunities to reach new people in new places  
14 throughout the Annual Conference as try to develop new and emerging ministries.

15 **Fourth, support Digital Grants - \$150k.** The availability of these funds to local churches and ministries with  
16 hopes of enhancing digital storytelling of the gospel of Jesus Christ in the digital age.

17 **Fifth, in support of Conference Events/Emergency Funding - \$150k.** As of writing this report, we are working in  
18 committees to work out details for funding criteria for each of these buckets for funding the ministries for  
19 church development and redevelopment of local churches of our Annual Conference.

20 We as a committee continue to offer opportunities for MissionInsite orientation and training for the Annual  
21 Conference so that local churches, pastors and laity may better see, invite, connect, engage, know, disciple and serve  
22 the people of their communities better. We are planning for four tri-district training modules in the fall of 2025 at a site  
23 near you. So be on the lookout for the training dates in your areas.

24 We were be able to support four of our existing congregations who applied for grants through Existing  
25 Church Grants funds totaling \$120,000.00, grant support that span the spectrum of vital ministries, missional  
26 situations, and capital improvements to improve and provide needed support for people in our various  
27 communities across this conference.

28 Your generosity and financial investments from local congregations into our mission, ministries, and services  
29 of the people called United Methodist in South Carolina has allowed us to support local congregations in variety  
30 of ways. Thank You!!!

31 We are also grateful for your generosity and financial investments of \$245,144.53 through our new church  
32 and acquisition funds. This allows and gives us opportunities to support new ministries in new places for new  
33 people in the various communities in 2024-2025 around the state.

34 Again, these accomplishments are possible because of you and your local church's generosity and  
35 commitment to our God given mission of making principled and life transforming disciples of Jesus Christ for the  
36 transformation of the world.

37 While we celebrate all you have given and allowed us to collaborate with our sisters and brothers across the  
38 connection here in South Carolina through your generosity and investments, we also grieve another round of our  
39 siblings in our United Methodist Family in South Carolina and across the Connection who decided to disaffiliate or  
40 separate from our family. "Lord In Your Mercy! Hear Our Prayers!"

41 Yet, while we grieve the last round of disaffiliations and separations of this past conference year, we  
42 celebrate God's gathering of United Methodist and other people of faith who continue to love God, love  
43 neighbor, love oneself and love like Jesus across the Annual Conference.

44 We celebrate and support the following missional ministries in 2025 and beyond.

- **Carolina Forest** is a new church start in the Myrtle Beach area. First/Conway UMC is collaborating by being an anchor church and providing administrative support and shared space for this new church plant. Rev. Tyler Strange has been meeting with people, establishing relationships, creating an emerging core team in the Carolina Forest area.
- **The Circuit of the Rock Hill District** is a new missional situation pastored by Rev. Mallory Nickerson and Rev. Michael Jarrell. They currently have five small groups meeting. The Circuit is more of a missional rather than a typical new church start, meeting in small groups. They are creating church in the community similar mostly on the Fresh Expressions models of church.
- **Open Hearts/Greenville** is in its second year and seeing steady growth. They have begun a community ministry, Let's Break Bread, where they meet in homes for fellowship and discussions among several other ministry opportunities in the community.
- **Grace/North Augusta Sweetwater Satellite Campus** now has a new pastor appointed in the person of Rev. Patrick Taylor since July 1, 2024 and working with Lead Pastor Cathy Jamieson to bring a fresh approach of Evangelistic Love to the Sweetwater Community of Edgefield County and the North Augusta area.
- **Hartsville District Cooperative Parish** continues their good work under the leadership of Rev. Dr. Reginald Lee and staff, despite one of the churches dropping out.
- **Harris-Trinity/Greenwood** is a missional situation supported by Congregational Development and Equitable Compensation. It is a partnership between an African- American church and a Euro-American church under the leadership of Rev. Thessa Smith.
- **Good Samaritan/Lake Wylie** was receiving Congregational Development funds to support pastor's housing expenses. It is currently an interim closure and slated to be officially closed at Annual Conference in June 2025.
- **South Main Street Chapel and Mercy Center/Anderson** ended their 10-year support from the conference as a missional situation. They have requested permanent classification as a missional situation to assure financial stability. If granted, funding would continue from the conference level. I hope we can find a way to support a permanent missional status for this ministry under the leadership of Rev. Kurt Stutler.
- **Mt. Zion/Kingstree** received two years of support from Congregational Development as a part of a Renewed Vitality Situation under the leadership of Rev. Keith Hunter.
- **The Brook/Myrtle Beach** is a new church start that came as the result of a merger of three existing local churches in 2023 under the leadership Rev. Deborah Patterson.
- **O'Neal Street/Newberry** designated as a missional situation July 2024 under the leadership of Rev. Edward (Ed) Stallworth serves as pastor of the church and this mission.
- **Waters Edge/Lady's Island** receives support for property acquisitions for this church with hopes of having the mortgage paid off by the end of 2026.

As a Committee, we continue working to learn best practices from each other and our hope is to continue to expand the pool of resources, local church support, grant funding opportunities in each of our Districts in the Annual Conference. One of our goals is be the best stewards of what we have received from our local congregations of the annual conference and be as generous as we are able to support local congregations.

#### **Objectives for the coming year:**

Our goal is always continue and improve upon our ideals of being a resource for local churches interested in new ministry opportunities, and be a significant catalyst for the change and transformation needed to expand and extend the Kingdom of God through the Gospel of Jesus Christ in South Carolina. We will continue supporting our churches through every means of grace and resources God provides for us to support the local congregations.

One of the ways we intend to do this is our ongoing processes of getting more MissionInSite training for our Conference leaders, District Boards and local church leaders, both lay and clergy. It is still our hope to get all of our existing local congregations, new faith communities and faith expressions to plot their active membership and participants so that they and we may see, invite, connect, engage, know, disciple and serve all the people of our communities by loving them better on behalf of Christ Jesus.

1 We will continue supporting the current plants and partnerships across the connection, while prayerfully  
2 discerning our next faithful steps or projects as we prayerfully follow God's leading through Jesus Christ as the  
3 Holy Spirit empowers us, sometimes pulling and pushing us into the known and unknown world.

4 One of our major goals this year is intentional reflection on "**OUR WHY**" and how do we plan to fulfill God's  
5 Mission and Ministries through our Conference **four priorities, our values, our vision, and our purpose**.

6 We strive to see how they (**our four priorities, our values, our vision, our purpose**) align with God's  
7 promises given to us through the gospel of Jesus Christ our Lord, God's Holy Word and Will throughout the Old  
8 and New Testaments.

9 We hope to continue our learning best practices from within this Conference and conversations with other  
10 Conferences, so that we can continue making what is good better, and what is better the best it can be for the  
11 sake of Christ Jesus and Christ Church in the Wesleyan Traditions.

12 As in previous years and as we have opportunity to set aside some funds, we seek to fund opportunities for  
13 future leadership development, community engagement, developing pathways for connecting and growing  
14 principled disciples of Christ, measuring and evaluating current realities and missional possibilities.

15 We look forward with hope to partnering and sponsoring multiple smaller conference-like workshops on  
16 things like **staff/team development**, how to lead a visioning process, multi-site challenges, and multi-  
17 ethnic/culture transitions into **Acts 2** faith communities. We are excited about missional possibilities and  
18 opportunities before us even in such a time as this.

19 **Action(s) required from the 2025 Annual Conference:**

20 There are no specific actions or votes needed for our report, only submitting it to the record and for your  
21 prayers for our assignment going forward.

22 Know this, if there was one take away for you as a delegate it would be this, you can let us know what help  
23 you may need and ask how can we help you? We want to be a resource for you, your pastor, your staff, your lay  
24 leadership and the Church of Jesus Christ in your communities. That support could look like a variety of things:  
25 funding, training, coaching, or something we have not thought of yet. Whatever it is you are wrestling with, if  
26 you think we might be able to help, and then call us! We are here for you!

38 towards a smooth transition, in regard to housing and staffing information.

39 During this past conference year, this committee had the responsibility of carrying out its charge with two  
40 bishops. We planned and implemented the farewell of Bishop and Mrs. Holston, as well as the welcome and  
41 installation of Bishop and Mrs. Fairley. Both events went well.

42 Michael Jennings and Lollie Haselden did hands on work to get the parsonage ready for the transition. Each  
43 committee member aided in making the new episcopal family welcomed to be a part of the South Carolina  
44 Annual Conference.

1 Additionally, this committee was supportive of Bishop Fairley, in the loss of his mother, during the  
2 installation week.

3 We miss the Holstons yet open our arms and hearts to the Fairleys.

4 The budget for our work has been properly submitted.

## 8 THE COMMITTEE ON STANDING RULES

9 The Committee on Standing Rules offers the following Standing Rule change recommendations.

10 50. ~~The Board of Pension and Health Benefits shall be composed of eighteen (18) members nominated by the~~  
11 ~~Conference Committee on Nominations and elected by the Annual Conference. It is recommended that six~~  
12 ~~(6) be lay men, six (6) be lay women, and six (6) be clergy persons who are active participants in the pension~~  
13 ~~and group insurance plans in which the Annual Conference is the Plan Sponsor. There shall be a Board of~~  
14 ~~Pension and Health Benefits composed of not less than twelve (12) members nominated by the Conference~~  
15 ~~Committee on Nominations and elected by the Annual Conference. It is recommended one-third be laymen,~~  
16 ~~one-third be laywomen, and one-third be clergy persons who are active participants in the pension and~~  
17 ~~group insurance plans in which the Annual Conference is the Plan Sponsor. In addition to fulfilling the~~  
18 ~~responsibilities mandated by the *Book of Discipline*, the Board of Pension and Health Benefits shall supervise~~  
19 ~~the Annual Conference group insurance program. The Conference Benefits Officer shall be nominated by the~~  
20 ~~Board of Pension and Health Benefits and elected by the Conference Staff Relations Committee. The~~  
21 ~~chairperson of the Council on Finance and Administration shall be an ex-officio member with voice but~~  
22 ~~without vote.~~

23 **Rationale: This change was requested by the Board of Pensions and Health Benefits. It reduces the number of**  
24 **members on the board in response to a smaller conference. It also brings the language in line with**  
25 **that of the 2020/2024 *Book of Discipline*.**

26 46. There shall be an Annual Conference Ministry Advisory Team to facilitate conversation and interaction between  
27 Program Services, Administrative Services and Clergy Services. The membership shall consist of: The Resident  
28 Bishop, as convener; the Conference Lay Leader; the Conference Council on Connectional Ministries Convener;  
29 the Conference Director of Connectional Ministries; the Treasurer/Statistician; the President of the Council on  
30 Finance and Administration; the Chairperson of the Board of Ordained Ministry; the Coordinator of Clergy  
31 Services; the Cabinet President; the Secretary of the Annual Conference, and the Conference Benefits Officer;  
32 the chairperson of the Board of Pension and Health Benefits; and the Director of Congregational Development  
33 and the chairperson of the Committee on Congregational Development.

34 **Rationale: This change was requested by the Ministry Advisory Team to add the Secretary of the Annual**  
35 **Conference to membership. In recent years the work of the Ministry Advisory Team involved the Office**  
36 **of the Conference Secretary. Currently the Coordinator of Clergy Services and the Secretary of the**  
37 **Annual Conference are the same person, but does not have to be. This will insure the Conference**  
38 **Secretary is part of the Ministry Advisory Team in the event that the Secretary is not also the**  
39 **Coordinator of Clergy Services.**

## THE OFFICE OF CLERGY SERVICES

The primary purpose of the Office of Clergy Services continues to be to serve as a support for and liaison between the Bishop and Cabinet and the Board of Ordained Ministry in areas related to clergy licensing, ordination and status.

Mr. Sharome Henry, the Executive Assistant for Clergy Services, continues to provide excellent support to district offices and candidates with patience and passion. His concern for each of our candidates is expressed with through his willingness to help guide them through the process. He is a blessing to both to the candidates and to our church.

Our office inputs, updates and maintains the information in our database for all active and retired clergy, lay ministers, pulpit supplies and candidates in various stages of the process. That work is made possible by the help and guidance of Jim Crews and Russ McKissick in the Conference Information Technology department. The accuracy of this database is pivotal for the completion of the many annual reports for which this office is responsible.

This office continues to oversee the annual update of the clergy/candidates criminal background checks in accordance with the conference's Safe Sanctuary policy. The policy requires all active clergy, candidates and those assigned to congregations to have a current background check every three years. This year Clergy Services has processed over 400 background checks.

Clergy Services is dedicated to providing quality opportunities for leadership development. This office has also collaborated with the Chairs of the Clergy Orders and Fellowship to provide the first sexual ethics training of the quadrennium, led by the Interim Director of the Lewis Center for Church Leadership, Rev. Dr. Jessica L. Anschutz. Clergy Services also collaborated with the Board of Ordained Ministry to invite Dr. Lovett Weems to lead the main session at the 2025 Bishop's School of Ministry. In conjunction with the Board of Ordained Ministry, Clergy Services oversees the Licensing School of Pastoral Ministry. This year in addition to the quality instructors from among our clergy membership, we partnered with Candler and the Lewis Center to provide training for the new licensed clergy.

The work of this office is only possible with the assistance of the district admins. I am grateful for their work and for their diligent oversight of so much information, vital to so many different people. And it is a pleasure to work with our Bishop and Superintendents on many matters related to our clergy, and to attempt to support them as they continue the vital and demanding work necessary to identify, nurture, instruct and supervise the clergy of our Conference. The Conference Board of Ordained Ministry continues to seek the most effective and faithful ways to fulfill its remarkably broad role in evaluating and approving clergy to serve the local churches and various ministries of our Conference. The importance of this work cannot be overstated. The genuine concern and great wisdom of the members of the Board is continually demonstrated in the work that they do on behalf of the conference. The Rev. Morris Waymer continues to provide outstanding leadership to the Board. It has been a privilege to assist the Board in its work.

Without trying to list every event or undertaking of the past year, I continue to respond to requests by phone, email, and correspondence related to licensing, ordination, and all matters related to clergy and their status within the conference, and have met with individuals seeking personal guidance in these areas. It remains an honor to continue to encourage, guide and support clergy as they navigate, pursue and answer their calling. It has been a pleasure to serve in this area of ministry for the past five years, and I look forward to continued service in the coming year.

## THE SOUTH CAROLINA METHODIST CONFERENCE CREDIT UNION

The year 2025 marks seventy years of service by the South Carolina Methodist Conference Credit Union (SCMCCU) to the Ministers and their families, the churches and their members, and the institutions of the South Carolina United Methodist Conference.

The Credit Union was chartered on September 19, 1955, by ten elders of the South Carolina Conference (1785). The Reverend Hawley B. Lynn was elected to serve as the first President. Initially the Credit Union was chartered to serve ministerial members of the annual conference and others under appointment of the bishop, employees of the Boards and Agencies of the annual conference, and their family members. Today, membership encompasses not only the clergy of the South Carolina Conference and their families, but also members of the churches, and employees of the local churches, the Annual Conference, and the United Methodist Colleges, and Retirement Homes of the South Carolina Conference.

In 2024 the Credit Union grew in assets, and reserves while loans declined slightly. Because of increasing rates and improved operations, the credit union was able to increase dividends paid to our members by 244 % from 2023 on top of increasing dividends 230% from 2022! But more than numbers, this is an indication that we have been able to provide greater service to our members during the year. Service to our members will always be the focus of the credit union.

The credit union is currently blessed with a small, stable, and very experienced staff with a total of 100 plus years of combined experience working for credit unions and other financial institutions. This enables the credit union to provide exceptional service with a knowledgeable but personal approach. Alicia Reese serves as the Member Service Representative, Bruce Douglass serves as the Loan Officer, Christine Dominick serves as Operations Manager and Andy Cox serves as the President and CEO.

On February 27, 2025, the Credit Union's Annual Meeting was once again held at Epworth Children's Home. At the meeting, the members elected Board Directors, Credit Committee members and Supervisory Committee members. The financial condition of the credit union was reported. We encourage all members to attend the Annual Meeting to learn more about your credit union.

#### 18 **TRUSTEES OF THE SOUTH CAROLINA ANNUAL CONFERENCE**

19 To our Conference, Cabinet Members and Bishop Fairley,

20 We, The Trustees of The South Carolina Annual Conference have worked diligently to maintain the sacred  
21 trust of our conference. We are hopeful that the coming years will offer much in the way of healing any discord  
22 that separation caused. We extend to you our deep peace of this hope.

23 While The United Methodist Church has been in uncharted waters, we as a Conference Board have been  
24 asked to do things that have seldom or never been done. We have done all within the jurisdiction of an ethic of  
25 love and extending fair consideration to all. To the utmost, we have attempted to maintain the high ethical  
26 standards of the Conference and the United Methodist Church writ large.

27 Through *The Book of Discipline of The United Methodist Church* the Trustees are to hold in trust, along with  
28 the stewardship, administration, and investments, of assets pursuant to the properties of those churches that  
29 have elected to disaffiliate from The South Carolina Conference. In 2023, 113 churches chose to disaffiliate from  
30 the South Carolina United Methodist Conference. It was a part of the process to address from each church its  
31 financial obligations to both the conference and those who chose to remain in the conference. In 2024, there  
32 were 112 churches that chose to separate alongside the same financial obligations.

33 Decision 1512 put forth from the Judicial Council in October of 2024, cited that separations utilizing Paragraph  
34 2549 from the Book of Discipline are no longer allowed. The Judicial Council ruled that using Paragraph 2549 in this  
35 way was a "misapplication of law." It was deemed unconstitutional.

36 In an ad hoc committee of the Board of Trustees, funding from the separated churches has gone to  
37 unfunded pension obligations, reserves for Boy Scouts litigation, reserves for legal fees, and reserves for  
38 operating funds. Trustees have also met to establish best practices for remaining funds, including the litigations  
39 expected from the Judicial Council ruling alongside missions and ministry. We have done our due diligence to do  
40 no harm and to be good stewards of the funds remaining.

1 We have benefitted from the excellent leadership and insight of our Conference Treasurer, Chancellor, and  
2 Bishop. At times we have leaned upon the Cabinet, the Conference Secretary, Clergy Services, and many District  
3 Superintendents.

### 12 **JAMES L. BELIN BOARD OF TRUST**

13 The James L. Belin Board of Trust exists to ensure that ministry will take place as directed by the intent of  
14 the James L. Belin Trust and that all property of the James L. Belin estate, both real and personal, be directed  
15 and appropriated for the benefit of missions.

16 The James L. Belin Board of Trust met March 7, May 9, September 12, and December 11, 2024. As of March  
17 18, 2024 Vanguard moved charitable assets to Mercer Investments; the assets of the Trust are now overseen by  
18 Mercer Investments. Mercer Investments is a global consulting company and is well known in the institutional  
19 space. An external audit was conducted by the Brittingham Group in West Columbia. We completed a five year  
20 commitment to give Epworth \$110,000 towards an endowment for their Foster program. In 2025, the Belin  
21 Trust will complete a five-year funding plan for a Belin Endowment at the SC Methodist Foundation for  
22 scholarship funding for seminarians. The total endowment contribution over five years is \$50,000. In 2024 the  
23 net assets reserved for grants was \$231,266 for 2025. Challenges include that we pay a substantial amount in  
24 fees. We are considering other avenues to lower these fees. Also, much of the funds that are distributed  
25 through the Board of Global Ministries have recently been used for audio-visual equipment. We would like to  
26 hear more success stories from local churches about how they used the funds.

27 Objectives include continuing to look into ways that we can lower fees, and have a way to follow-up with  
28 local churches use of funds so that the Belin Trust can be a better partner in ministry.

29 There are no actions required from the previous Annual Conference.

30 The James L. Belin Board of Trust would like to be a partner in your ministry. Please contact your District  
31 Superintendent to find out how to apply for funding for your next ministerial project.

### 33 **THE UNITED METHODIST CENTER BOARD OF TRUSTEES**

34 The United Methodist Center Board of Trustees works to provide office space for the South Carolina  
35 Conference of The United Methodist Church, and to operate, supervise and maintain such facilities, renting the  
36 space therein to offices, agencies, and affiliates of the Conference.

37 The Trustees have completed several projects during 2024. The Trustees continued to seek energy savings  
38 incentives available through Dominion Energy with lighting upgrades to LED bulbs. The gutters were cleaned and  
39 repaired. The carpets and floors were professionally cleaned. However, maintenance and repair expenses for  
40 HVAC continue to be a challenge.

41 The Trustees modified the rent charged to the offices and agencies in the building in 2024. In preparation for  
42 the change in rents, the office space was measured and assigned to the appropriate occupant, the common  
43 areas were measured and allocated to the occupants, and a new rent per square foot established. The rent per  
44 square foot in 2024 was \$8.50 per month.

We continue to monitor the efficacy of major building components such as the heating and cooling. We recognize the building is approaching an age where renovation and/or refurbishment will be needed. The Trustees will seek alternatives for office space with the goal of reducing the cost. However, this project is paused while we await decisions from the Jeremiah Teams that may influence future office space and meeting needs.

The Trustees are at work to provide the space needed in cost effective ways and to be excellent stewards of the fund provided.
